Subject: Communication of execution occurred of merger operation of incorporation the company Magis Farmaceutici Srl into the company Aesculapius Farmaceutici Srl.

As a consequence of this incorporation and pursuant to the current Privacy Code (EU Regulation 2016/679), the company Aesculapius Farmaceutici Srl also takes over the ownership of the personal data already subject to processing by the incorporated company, however, the purposes and methods of processing remaining unchanged pursuant to the information already communicated.

Following the aforementioned merger by incorporation operation, **from 1 October 2023 only Aesculapius Farmaceutici Srl is operational, to which reference must be made for any commercial relationship, even if it arose before that date.**
